2019/20 Season (League Matches and Clarification of Final Standings)

Looking back at the end of the 2019/20 season which was cut short due to the COVID-19 pandemic, it was decided that due to a number of teams not returning, that the current standings in each division would be how the leagues will finish and prize money will be paid to those teams in the top 3.

There was a lengthy discussion as to why games would not be finished as some teams argued that they could still finish in the top three but as we have quite a few teams that are not re-entering the league this causes issues as to how these matches would be resolved.

In theory those teams who are unable to field a team or return to the league would go down as a 7-0 defeat. The problem is this wouldn't just have an impact on the team competing in those games, it would also have an impact on other teams who would be in the mix or have a chance of changing positions if a default result was awarded.

We would then need to decide if all matches including the teams who are not entering would need to be voided however as these are exceptional circumstances it isn't fair when they have already fulfilled these fixtures. Therefore, the general consensus and agreement was to finish the league matches with the current standings and move onto next season.

With this being the case, please join me in congratulating the following teams who had excellent seasons in their respective divisions.

Division 1 Champions – Woolston A Runner up – Monks A Third Place – The Grange

Woolston A had an excellent season in becoming champions of the Warrington Snooker league. They were by far the best team in the division securing the title with a game to spare. A special mention goes to **Mark Leathem** who went undefeated throughout the campaign winning all of his 16 league games, which is a fabulous achievement. With competition matches scheduled to be completed, they will be looking to add the team championship cap off a wonderful season.

Following promotion in the previous season, **Monks A** had a brilliant season in being runners up which included victories in each of their opening seven games which is very credible on their return to the first division. Their second half of the season wasn't quite strong enough to keep on the coattails of Woolston A but still a fabulous effort to get second place.

Third place went to **The Grange** who's only defeat in the second half of the season was to the champions Woolston A. They won their final eight games on the bounce to turn their season around and secure a top 3 position and **Ian Hall** won an excellent 17 games this season to be player of the year in the division. They are due to play Woolston A in the team championship final so still have a chance of silverware in what should be a high quality match.

Division 2

Champions – GESM C Runner up – Warrrington Cons A Third Place – Cadishead Cons **GESM C** had a wonderful second half of the season only losing one game since the turn of the year on the way to winning the second division. Within their ranks, **Stewart Garnett** won 16 of this 19 league games to be the division 2 player of the year. Unfortunately GESM C are not returning to the league due to a number of players who can no longer commit but go out on a high having finished top of the division.

Warrington Cons A were another team who had excellent form post-Christmas to give themselves a chance of winning division including picking up 13 points in their final two games. Their only defeat in the second half of the season was against GESM C, which effectively decided the final standings so were very unlucky not to be top of the pile.

An excellent start to the season in which **Cadishead Cons** picked up 26 points from their opening five games helped them finish in the top three playing game less than most of their rivals. Cadishead Cons, who next season will be playing at Irlam Steel, will be looking to challenge in the first division and a start as good as the 2019/20 season will help them achieve this goal.

Division 3

Champions – Mad Hatter A Runner up – GESM B Third Place – Alford B

Mad Hatter A had the best form across all three divisions winning each of their last 10 league games on route to winning the third division in only their second season in the Warrington Snooker League. Hatter A who had a game spare on their closest rivals, only lost a credible three games all season which was the least across all divisions.

GESM B put the disappointment of being relegated from the second division in the 2018/19 season to bounce back and finish in the top three at the first time of asking. For a team that had struggled for consitancy over the last few seasons it was a rewarding season for them to finish runners up.

Having won 12 league matches, **Alford B** just pipped Warrington Cons to third place on the most wins by one game with both finishing on 75 points. Both Philip Oakes and Chris Taylor registered an impressive 14 wins each for Alford and were integral to their success across the season.

A special mention to **Eric Callon** (St Benedicts) who pipped both Phil and Chris to player of the year in Division 3 with 15 wins from his 18 frames.

2019/20 Season (Competition Matches)

As most players who were still in the competitions are still playing for their respective teams and that these are down to the semi-final / final stages, it has been decided that all the remaining competition matches will be finished towards the end of September/beginning of October (dates TBC).

2021/22 Season (Team Registration – Thursday 2nd September 2021)

As mentioned earlier, out of the 33 teams that played in the 2019/20 season, 24 teams have confirmed that they will definitely be entering a team back into the league. With this being the case, it has been decided that the Warrington Snooker league will now be split across just two divisions.

Finances

Graham is to speak with each team captain that need to pay any outstanding fees from the 2019/20 season.

He will also be in touch with each team that has won prize money for league standings and once the competition matches have been played.

Team registration fee for the 2021/22 season will need to be paid no later than the October 2021 meeting.

Future Lockdowns and COVID-19 Issues

The committee will meet to discuss how the league will move forward should any further lockdowns or COVID-19 issues occur during the next season. Some areas to think about are if any lockdowns happen over the winter months and if the season will be extended later into the spring.

At one of the meetings in the next couple of months, we will discuss with team representatives what our thoughts and suggestions are, as well and taking advice and ideas from those present.

We also need to consider if any players/clubs are unable to host matches due to COVID-19 cases and how these will be treated/rearranged.
